As you are all aware, we are being inundated with solicitations from all the Healthcare Plans about the new Medicare Plan D. I won't attempt to explain anything about it but will advise that no matter if you sign up for the plan or not, it has no effect on your City of Chicago Health Care Plan. The fact of the matter is that your City Health Care Plan is cheaper and will cost you less money.

**Pension News** by *Trustee Ken Hauser*

By the time you receive this newsletter, I will have started my term of office on the Pension Board. On October 27, 2005, the ballots were counted for the Pension Board election of Trustees. There were 5,709 votes cast for the Trustee representing all of the annuitants. I received 3,931 votes, which overwhelmingly elected me to a three-year term of office. I'd like to thank you for your vote of confidence. My term of office begins on December 1, 2005 and will extend until November 30, 2008. I thank everyone who worked for my election, especially my Committee Chairman, Jim O'Leary. I also thank all the police organizations for their endorsements and the numerous friends on my committee who spent many long hours working for my victory.

I have some good news for annuitants born after January 1, 1950. The second half of the Veto Session concluded on Friday, November 4, 2005. Before adjourning, pension legislation was passed that benefits retired Chicago Police Officers. The legislation that will affect police officers the greatest is the 3% automatic increase in the retirement annuities for those officers born before January 1, 1955. A police officer will begin receiving the 3% annuity increase upon the first of the month following the first anniversary of his/her date of retirement if age 55. A police officer will continue to receive the 3% annuity in January of each year thereafter and shall not be subject to any cap (maximum amount). The 3% cost of living adjustment (COLA) will be calculated as a fixed yearly annuity based on your annuity at retirement. This is not a compounded annuity. This COLA will be retroactive to January 1, 2005. This Bill was sent to the Governor's desk for his signature. The Governor has 60 days to sign the Bill or it automatically becomes LAW without his signature. I would like to thank all the Senators and Legislators who made it possible to make this Bill LAW, especially the sponsors.

As we were going to press I was informed that at the Pension Board meeting of November 29, the trustees approved my September 22nd proposal of a thirteenth check in December. All annuitants receiving \$1,200.00 or less will receive a \$400.00 check by December 31st. May your holidays have an abundance of food and spirits enjoyed with good friends, little work and much family time. Wishing you and your family holiday happiness and good health in the New Year.

**Greetings from the Call Center**

Hello Members of the Retired Police Association! By now, you may be well aware that the Credit Union established the Call Center in November 2003. The Call Center was created to accommodate the more than 10,000 calls that were offered on a monthly basis. The Call Center Representatives have been trained to handle a myriad of issues for the convenience of the members. Some of the transactions that the agents take care of during the course of a phone call include: transfers between accounts, opening new Share Certificates, processing loan applications, re-setting passwords for the Home Banking Product, processing payroll changes, and processing Visa Classic applications.

With all of the products and services that the Credit Union has to offer, it is important for *all* members to realize what resources are at their disposal. In particular, it is important for members of this organization to understand what the Credit Union's Call Center can do to help them reach their financial goals.

What are the things that the Call Center can do to help members of the Retired Police Association? There are several things that the agents can do to assist these members. For instance, the agents can help retired police association members open new credit union accounts. In addition, the agents can also process paperwork that will initiate direct deposit or payroll deductions for their accounts. The Call Center Representatives can also initiate contact with our Financial Planners at the Financial Planning Center, who can assist in the investment of funds received from deferred compensation or other sources. The planners are trained to help our members invest their funds wisely. The representatives can also give the members basic information regarding Share Certificates rates and penalties as well as the rates of IRAs (Individual Retirement Accounts).

These are just a few tools that the members of the Retired Police Association have at their disposal. We hope that the organization looks to make full use of these resources.
