Most of us have received our Social Security retro checks. But there are still some that are still waiting. I wish there was a magic answer but Social Security states that we need to be patient. Rostenkowski passed the bill in 1983 that screwed us in the U.S. House. When the bill went to the U.S. Senate Joe Biden voted for it too. In 1993 Biden voted again to raise the taxes that had to be paid on Social Security. In 1993, then a U.S. Representative, Dick Durbin voted to raise the taxes on our Social Security benefit. President Trump has proposed that Social Security benefits should be exempt from Federal taxes. Please reach out to your U.S. Senator and ask them to support the bill to exempt Social Security benefits from Federal taxes! (Dick Durbin @ (202)224-2152 and Tammy Duckworth @ (202)224-2854). To find out who your U.S. Representative is google (who is my U.S. Representative is? Then enter your zip code. At the same time, you should ask YOUR elected officials to end the taxes on Social Security, ask them to end the Pill Penalty they snuck into the Inflation Reduction Act. All the major Insurance companies raised their premium's last year because of that bill. On the pension front the City made all their statutory requirements for last year and the investment return was 10.54%. As of 14 April 2025, the City has made 53.38% of their required payments for the 2025 calendar year in the first three months. This was a pleasant surprise. But knowing the City's budget problems we must all be vigilant! If you live in the city and run into an alderman tell them we need more police officers. The city is about 1830 officers short!

# IMPORTANT THINGS TO REMEMBER IF YOU ARE ENROLLED IN ANY OF THE VOLUNTARY DENTAL, VISION, OR MEDICARE PROGRAMS SPONSORED BY THE CHICAGO JOHN DINEEN LODGE NO. 7

- Dental, Vision and Medicare with Aetna are voluntary and are not part of your City of Chicago Retiree Healthcare package. Participation in these plans typically begins when contractual healthcare benefits are no longer available to the retireee.
- It is the member's responsibility to keep their personal contact information up to date with both Source 1 Benefits at 844-466-0833 and Retireee First at 855-979-8840 (TTY 711).

Please note: The Pension Fund and the FOP do not share your contact information with the plan administrators.

• Dental and/or Vision: If the primary member (retiree) passes away while enrolled in a plan, the surviving spouse is eligible to continue coverage. However, dental and vision coverage ends on the date of death.

The surviving spouse must contact Source 1 Benefits to re-enroll under their spousal annuity. Call the Srouce 1 Benefits Helpline at 844-466-0883 for assistance. It is the responsibility of the retiree or surviving spouse to notify Source 1 Benefits and request continuation of coverage or changes in coverage.

• The Medicare program operaates differently, as both the retiree and spouse have individual account numbers linked to their unique Medicare ID numbers.

In the event of a death, Retiree First must be notified so they can assist in coordinating continued coverage. Contact Retiree First at 855-979-8840 (TTY 711).

Well, it seems the Chief Yolanda Tally investigation is over. They promoted her to First Deputy! She screwed up IAD and her oversight of recruits has made the department worse. How many more must suffer before she files for her Gold Braid pension further diminishing the solvency of our pension fund? The media said she was cleared! What about the PPP fraud allegations? actions regarding the traffic stop? The officers did. Rumorsabound that when they dump Supt. Snelling, she will take his place.

There is a bill in the Illinois House (HB1611) that will govern search warrants. One part of the bill states that a search warrant can only be executed between 9 AM and 7 PM. HAH! Never have County Board President Preckwinkle or Shariff Dart mentioned the cost. Recently, electirc monitoring was taken over by Chief Judge Timothy Evans.

He has trouble overseeing the judges in his courts and he's going to handle prisoners that his judges have released to our streets. Keep your dorrs locked, head on swivel, and powder dry!


